# On April 4, the Oconto Falls School Board will ask district voters to consider a referendum question.

If passed, the referendum would allow the district to exceed its revenue limit by a total of \$11.5 million over five years in an effort to stabilize the district's finances and protect the district's offerings. The referendum would replace an expiring referendum that voters passed in 2014.



### Vote on April 4!

#### **BACKGROUND:**

In recent years, the Oconto Falls School District has faced financial challenges. While the school board has taken action to address the district's most urgent financial needs, the district's long-term viability requires the attention of the entire community. Over the years, the district has used the authority provided by Act 10 to cut positions, reduce benefits, and implement salary freezes and below-the-cost-of-living increases. Despite these cost-saving measures, the district has continued to face financial challenges.

#### THE NEEDS:

In 2014, voters in the district approved a three-year operational referendum to increase the district's revenue-limit authority by \$400,000 in order to make roof repairs and address some technology needs. Yet, despite efforts to cut costs, the district's 2015-16 school year revenue-limit authority was \$17.2 million, which was lower than the 2010 level and included the \$400,000 provided by the referendum. In 2016–17, the district's financial projections showed a \$450,000 deficit, and the board balanced its budget through staffing reductions (resulting in higher pupil-teacher ratios), technology changes, changes/loss of programming and additional staff benefit changes.







#### WE LISTENED:

In the fall, the district conducted a survey in which nearly 900 community members participated. The input from the surveys was instrumental in the development of a solution, which will be placed on the April ballot.

### What Are the Next Steps?

On April 4, members of the Oconto Falls School District will vote on a referendum question. If the referendum is approved, it will provide a total of \$11.5 million over five years in additional revenue-limit authority. **In an effort to protect the school district and local taxpayers, the referendum, if passed, will provide funding for four key areas.** 



#### **BUSES:**

The school district's buses, while well maintained, are quite old, and many are nearing the end of useful service.

As a result, the district could be forced to replace many buses simultaneously, which would create a challenging budget situation. We believe it is best to replace some of the buses now and create a replacement plan for the others; this approach would allow the district to better address budgeting for bus replacement.

### TECHNOLOGY:

It is essential that the district's technology infrastructure is upgraded. Technology is increasingly important for our students, and we must create an environment in which technology is updated on an ongoing basis as a part of our budget process.

#### **CURRICULUM:**

In order to ensure that our students gain the knowledge and skills necessary for success in the future, we must continually update and improve our curriculum.



#### MAINTAINING FACILITIES AND OPERATIONS:

Simply put, as a result of declining revenue-limit authority, the board has been forced to defer maintenance on our facilities. The passage of the referendum would allow the board to address urgent facility issues.



### What Are the Costs?

If passed, the referendum will result in an increase of \$23 per every \$100,000 of assessed property value for each of the next five years and help ensure the long-term viability of the Oconto Falls School District.

## Nothing Says "**FUN**" Like a Blue Ribbon Pie in the Face

Oconto Falls Elementary School celebrated its place among the best in the nation with whipped cream pies galore.

The elementary school was one of only eight schools in Wisconsin and 329 in the nation to be named a Blue Ribbon School. The award was presented in 2016 to recognize the elementary school's progress in closing achievement gaps among disabled and non-disabled students and economically disadvantaged and non-economically disadvantaged students.

School officials passed up a Blue Ribbon awards ceremony in Washington, D.C., choosing instead to involve everyone in a celebration on March 3 in the school's gymnasium.

Staff members speaking at the Blue Ribbon assembly emphasized four things students are asked to do:

- Work hard in academics
- Develop talents and be creative
- Help others
- Have fun

"Those are the things that make our school special. They make us a great school," Principal Dan Moore told the 500-plus kids at the assembly.

The pie-in-the-face party was all about fun – sweet, messy fun that filled the kids with glee. A student from each class was chosen to put a pie in the face of a staff member who volunteered to be the butt of the prank. The whole school shouted out a countdown and then cheered as the pies hit their targets, leaving the teachers wearing white masks of whipped cream and getting everyone laughing.
